# **BEZMIALEM VAKIF UNIVERSITY**

APPLICATION, ACCEPTANCE AND REGISTRATION OF STUDENTS FROM INTERNATIONAL OR FOREIGN RESIDENTS

FIRST PART

Purpose, Scope, Basis, Definitions

Goal

ARTICLE 1: (1) The purpose of this directive is to specify the application, registration and acceptance principles to be applied to the admission of foreign or foreign students to associate and undergraduate programs within Bezmiâlem Vakıf University.

Scope

ARTICLE 2: (1) This directive covers the principles and rules governing quotas, application and acceptance of foreign or foreign students.

Base

ARTICLE 3: (1) This Directive No 2922 Studying in Turkey Foreign Law regarding the students and 04/30/1985 date, 18740 numbered Official Gazette published the study in Turkey Goren Foreign are based on the Code of Student.

**Definitions** 

ARTICLE 4: (1) In this Directive;

- a) University: Bezmiâlem Vakif University,
- b) Board of Trustees: The Board of Trustees of Bezmiâlem Vakif University,
- c) Rector: Bezmiâlem Vakif University Rector,
- ç) Board of Directors: Board of Directors of Bezmiâlem Vakif University
- d) Senate: Bezmiâlem Vakif University Senate,
- e) Unit: Faculties and Vocational Schools within Bezmiâlem Vakıf University,
- f) Board of Directors of the Unit: Bezmiâlem Vakıf University, the board of directors of the faculties and vocational schools,

- g) Program: Diploma program at Associate and Bachelor level,
- h) Candidate: Bezmiâlem Vakif University High school senior or high school graduate who wants to participate in Foreign Student Examination and is a foreign national,
- ı) TRNC: Turkish Republic of Northern Cyprus,
- i) YÖK: Council of Higher Education,
- j) ÖSYM: Student Selection and Placement Center,
- k) Ministry of National Education: means the Ministry of National Education.

#### SECOND PART

Guidelines for Admission, Admission and Registration of Students from Abroad or Foreign Students

#### Quota

ARTICLE 5: (1) The quotas for international or foreign students to be admitted to Bezmiâlem Vakıf University shall be communicated to the Council of Higher Education (YÖK) for publication by the Senate and published in the Student Guide to be Accepted Abroad.

(2) In the event that a quota is not applied to a student who has taken a program for the acceptance of foreign students or foreign students, or if the quota is not filled, the non-filled or non-applied quotas may be added to the other program quotas of the university upon approval of the university.

Basic Conditions for Application

ARTICLE 6: (1) From candidates who wish to study undergraduate and undergraduate education in our country with their own possibilities;

- A) Provided they are in the final year of high school or are in graduation;
- 1) Foreign nationals,
- 2) Those who are Turkish citizens at birth and who are allowed to leave the Turkish nationality from the Ministry of the Interior and those whose underage children are registered under the Turkish nationality certificate under the Turkish Citizenship Act

Who certify that they have a document on the Exercise of Rights (5901 numbered Turkish Citizenship Law of Article 7 "(1) in Turkey or abroad Turkish citizens A child born Turkish citizen of wedlock is a mother or father" is located provision, the Turkish Citizenship Applicants to accept quotas abroad There is a benefit in examining the law),

- 3) Citizenship acquired afterwards in the case of foreign nationals and / or citizenship of the citizenship of the Turkish citizenship / in this case.
- 4) Those who are Turkish citizens and who have completed at least the last three years of secondary education (high school) in a foreign country other than TRNC, including those who completed the secondary school (high school) in Turkish schools opened in MEB in a foreign country other than TRNC)
- 5) Nationality of TRNC; Applicants who are residing in the TRNC and who have GCE AL exam results who have completed secondary education in the TRNC and those who have obtained or trained GCE AL exam results by enrolling in colleges and high schools in other countries between 2005 and 2010 will be evaluated.
- B) From the candidates;
- 1) T.C. all citizens who have completed secondary education in Turkey or the TRNC,
- 2) K.K.T.C. (those who have finished their secondary education in KKT.C high school and those who have GCE AL result and enrolled in college and high school in other countries between 2005 and 2010,

owned or owned),

- 3) The first nationality of T.C., defined in item 2 of article A by birth. (except those who complete all secondary education in a foreign country other than TRNC and complete all secondary education in Turkish schools in a foreign country other than TRNC)
- 4) One of the K.K.T.C. (except for those who have finished their secondary education in the Turkish Republic of Northern Cyprus and who have GCE AL results and those who have enrolled and trained in colleges and high schools in other countries between 2005 and 2010 and have or will have GCE AL exam results)
- 5) within the schools in the embassies of Turkey sees their high school education in foreign nationals in Turkey T. C nationality by birth or who first defined in paragraph 2 of Article No. T. C. are not taken into consideration for the applicants of the dual citizenship.

Exam Types and Base Points to be Accepted in the Application

ARTICLE 7: (1) The evaluation of applications made within the scope of this directive shall be made on the basis of diplomas and examinations approved by YÖK. Such diplomas and accepted exams and the minimum requirements for these exams

(2) Candidates who do not have the diplomas and examinations approved by the Higher Education Council (YÖK) must take at least 70 points from the YÖS examination to be made by the University.

(3) The exams that have the status of university entrance exam (SAT, etc.) are valid for 2 years. There are no limitations on the validity of exams that are in the status of high school final exams (ABITUR, International Baccalaureate, GCE, TAWJIHI etc.). The examination made by the university is only valid for the relevant semester.

**Application Forms and Application Documents** 

ARTICLE 8: (1) Applicants shall be made by filling in the online application form opened at the website of Bezmiâlem Vakif University International Relations Office between the dates specified in the academic calendar of Bezmiâlem Vakif University.

(2) Candidates may apply up to three programs. These programs are specified in the "Application Form for Foreign Students or Foreign Students".

- (3) Documents required for application, if any, special conditions and explanations are announced on the website of the university.
- (4) The minimum documents required for application are;
- a) Foreign Student Application Form filled online by the candidate,
- b) The example of the high school diploma (the educational status document to be received from the schools for the graduate students at the application date)
- c) Transcripts of official transcripts showing the courses and grades the candidate has attained in high school, translation in Turkish or English,
- d) 1 passport-size photograph (must have been taken within the last 6 months, easily identifiable)
- e) Photocopy of the page on the passport where the photo and identification information is located
- f) Receipt of application fee determined by the Senate
- g) Certificate of applicants' English language proficiency (if any)
- ğ) Documents related to the applicants' Turkish language proficiency (if any)
- i) Reference letter (if any)

Preliminary Examination and Placement

ARTICLE 9: (1) Preliminary examination, evaluation and application of the candidates applying for the programs that the university will accept from abroad or foreign students will be conducted by the commissions authorized by the Rectorate.

- (2) Obtaining the conditions of application does not constitute a right for placement of the program.
- (3) Candidates who are found not to bear the application conditions at the end of the preliminary examination shall not be evaluated.
- (4) In the event that the applicant satisfies the conditions for applying more than the quota of the relevant faculty / department, a separate quota for each country can be determined and interviewed by the commissions authorized by the Rectorate.

## Student Admission

ARTICLE 10: (1) The results of the application will be notified to the candidates in writing. The results will also be announced on the web page of Bezmiâlem VAKIF University.

(2) A letter of acceptance will be sent to accepted applicants by the Bezmiâlem VAKIF University. Candidates, this acceptance

Turkey Foreign Representative by going to their country with the letter "Student Visa" may need to take. in Turkey

candidates can get a study visa from Provincial Security Directorates.

(3) The evaluation of applicants and the placement of candidates is entirely at the priority of Bezmiâlem Vakif University.

The university is free to fill and fill the quotas. Obtaining the application conditions does not have to be accepted for placement.

## Record

ARTICLE 11: (1) Records are made on the dates announced by the university website, in the relevant units. The documents required for registration are published on the website together with the results.

- (2) The minimum documents required for registration are:
- a) High School Diploma of (temporary certificate of diploma prepared yet for the new graduate students in historical records) with their original countries or Turkey notary certified Turkish translation of the Foreign Representative,
- b) High School Diploma, T.C. The certified sample of the "Equivalence Certificate" obtained from the Ministry of National Education, Provincial National Education Directorates or Turkish Foreign Representatives,
- c) It shows the courses and grades that the candidate has attained in high school, the official transcript certified by the high school administration and the example of the Turkish translation notarized in its own country or approved by Turkish Foreign Representatives,
- ç) The test result document stated in the seventh article shall be authentic,

- d) Passport identification and validity pages and the translation of the Turkish translation into a notary in its own country or approved by Turkish Foreign Representatives,
- e) The Turkish Proficiency Certificate (if any) specified in the Fourteenth Matters,
- f) English Proficiency Certificate (if any)
- g) Certificate of residence (must be delivered to the relevant units within one month from the date of registration)
- ğ) 12 pieces 4,5 x 6,0 photographs,

- h) A document stating that the financial obligations envisaged in the law and specified by the Board of Trustees are met,
- 1) Additional documents required by the related department to be trained for registration,
- i) Livelihood Assurance Certificate.

Tuition Fee and Living Assurance Amount

ARTICLE 12: (1) Tuition fees are determined by the Board of Trustees every year.

(2) It is necessary for the students who will apply to the university from abroad to have the financial means that they have the financial means to maintain their higher education.

Teaching Language and Turkish Proficiency Level

ARTICLE 13: (1) The university teaching language is English and Turkish.

(2) Yunus Emre Institute is determined according to the exam result made by a jury established by the Ministry of National Education or by the University Senate, from centers that provide Turkish education accepted by YÖK (TÖMER etc.). For those students whose Turkish level is not enough, an additional period of one year is granted. During this period, the university that starts Turkish course starts studying after certifying that they are successful in the courses given by institutions that are accredited by the Ministry of National Education or the Turkish Education Centers accepted by YÖK (TÖMER etc.). At the end of this period, those who fail will be disconnected from the University.

English Proficiency Level

ARTICLE 14: (1) English proficiency of foreign students is measured by the English Level Determination and Proficiency Exams. The minimum scores required to be successful from the exams are determined by the Senate upon the recommendation of the Department of Foreign Languages.

(2) The candidates described below are exempted from the English Language Assessment and Proficiency Examinations at the Bezmiâlem VAKIF University:

- a) Those who, at least in the last three years, have studied in a country where English language is spoken as a mother tongue, in education institutions where the citizens of that country continue, and who have graduated secondary education from these institutions,
- b) those who have a TOEFL and IELTS test result for the purpose of determining the minimum level of English language required for foreigners to be able to see higher education in countries where the English language is spoken as a native language (the minimum score required for qualification is 75 for the TOEFL IBT and 6 for the IELTS).
- c) Those who are successful in the English Proficiency Exam at Bezmiâlem Vakıf University,
- (3) Bezmiâlem Vakif University Students who have achieved sufficient success in the English Language Placement and Proficiency Examinations and those who are exempt from these exams begin their undergraduate studies directly. Others study at the English Language Preparatory Program.

THIRD PART

Miscellaneous and Final Provisions

Non-Determined Courts

ARTICLE 15: (1) In the cases where there is no provision in this directive, the relevant provisions of other legislation and the decisions of the Senate shall apply.

Enforcement

ARTICLE 16: (1) This directive shall enter into Enforcement with the decision of the Senate, dated April 15,

Executive

ARTICLE 17: (1) The provisions of this Directive shall be executed by the Rector of the Bezmiâlem VAKIF University.
