

## INTER-INSTITUTIONAL EXTERNAL TRANSFER APPLICATIONS

Transfer between Associate and Undergraduate Degree Programs in Higher Education Institutions is carried out in accordance with the principles and decisions of the Regulation on the Principles of Double Major, Minor and Inter-Institutional Credit Transfer of the Bezmialem Vakif University Transfer Between Associate and Undergraduate Degree Programs.

## **Eligibility for Application**

- 1. To be in the status of "registered student" in a higher education institution,
- 2. For Associate Degree and Undergraduate Programs; The condition is that the student must not be less than the lowest base score of the diploma programs of other universities in the country, and that he/she has completed all the courses in the program he/she is enrolled in. He/she must have a GPA of at least 2.50 out of 4.00. (or the equivalent)
- **3.** Mandatory English preparatory program is applied in our Faculties of Medicine, Dentistry and Pharmacy. For transfer students to start the department directly, it is necessary to pass the English proficiency exam announced by the Department of Foreign Languages or to have the relevant score in the specified exams and certify it during the application.
- **4.** Students who are accepted to our university as transfer students pay the tuition fee that is determined for the relevant year based on the year of placement in the department/program for our current students, over their own entrance years.
- 5. Students who are accepted to our university as transfer students pay the fee per ECTS for the courses they will take during the adjustment process, and the tuition fee determined for the relevant year based on the year of entry to the department/program for our current students, over their own entrance years.
- 6. Students who have settled in another university with the status of foreign student, but are accepted to our university through lateral transfer, pay the tuition fee determined for the relevant year, based on the year of entry to the department/program for our current foreign students, over their own entrance years.
- **7.** <u>The</u> university accepts the equivalence of the diploma program to which he/she is registered to the associate and/or undergraduate degree diploma program for which he/she has applied for transfer.
- **8.** During the application of transfer students to our university, the following equivalent documents will be sought. Applicants must have ÖSYS/YKS score for the year they started their education abroad, (For associate degree programs and undergraduate departments)

- **9.** Students are required to meet the conditions announced in the YKS guide for the year they enrolled in a university abroad.
- **10.** In order to be able to transfer from a higher education institution abroad to a program in our country, success ranking is required as in the following:
  - a. In the year the student starts his/her higher education, the ranking institutions (Times Higher Education Board) taken as basis by the Higher Education Council of the university he/she is registered to . Education (THE), QS World University Rankings, Ranking of World Universities (ARWU) CWTS Leiden Ranking) to be in the first four hundred slices in at least three of them, and to meet the term/class and success conditions in the "Regulation on the Principles of Transfer between associate degree and Undergraduate Degree Programs in Higher Education Institutions.
  - **b.** In case of being registered in a university other than the first four hundred slices;
    - i. Those who have completed their secondary education in Turkey must have taken the central placement exam in any case and have met the condition of success ranking in the relevant score.
    - **ii.** Those who have completed at least the last two years of their secondary education abroad must have successfully passed at least four semesters of the diploma program they are enrolled in, excluding the preparatory class.
- 11. Students must have Turkish translations of all their documents.



## **Documents Required for Application**

- **1.** Passport Photo, (*To be uploaded to the application system*)
- 2. ÖSYS/YKS Placement Result Document,
- **3.** ÖSYS/YKS Result Document, (The document showing the relevant score type for applicants who apply to programs that accept students with different central placement score types)
- **4.** Copy of High School Diploma, (Graduation certificate obtained via e-government)
- 5. New dated Student Certificate, (Original language and notarized Turkish translation)
- Disciplinary Record Document from your current University (Original language and notarized Turkish translation)
- 7. New Dated Certified Transcript, (Original language and notarized Turkish translation)
- 8. Approved Course Contents, (Original language and notarized Turkish translation)
- 9. Copy of Identity Card,
- **10.** Passport Copy, (Copies of pages with entry and exit stamps)
- 11. Equivalency certificate for the recognition of the university, (YÖK)
- 12. Document showing that students' current university is in the first four hundred slices in at least three ranking institutions that Higher Education Council of Türkiye accepts. Accepted ranking institutions by the Higher Education Council of Türkiye are Times Higher Education (THE), QS World University Rankings, Academic Ranking of World Universities (ARWU) WTS Leiden Ranking)

## **Evaluation and Results for External Transfer Applications**

1. The GPA, starting from the highest average. If the GPA of the candidates at the quota limit is equal, the GPA of the last semester in associate degree programs and the GPA of the last year in undergraduate programs is taken as the basis and the higher one is taken as the basis.



Applications with missing documents will not be taken into consideration. It is the applicant's responsibility to submit all required documents before the application deadline.

Accepted students are announced on the web page and complete their registration on the specified dates.

Candidates who do not register on the announced dates will lose all their rights.

Since notifications will be made via e-mail in External Transfer process, it is highly requested that your e-mail address is defined correctly in the system and that your e-mail accounts are checked during the process.
