

# Application and Registration Admission Directives for Graduate Students to Benefit from Future Scholarships

UTILIZATION OF UNDERGRADUATE STUDENTS

RELEASE APPLICATION AND REGISTRATION ACCEPTANCE

Goal

ARTICLE 1 - The purpose of this directive is to apply to the graduate school of BEZMIALEM VAKIF University

and to determine the principles and principles regarding the scholarship and discount rates to be provided to the students who are admitted to the programs.

Scope

ARTICLE 2- This directive covers arrangements relating to scholarships applied at BEZMIALEM VAKIF University undergraduate programs.

Scholarship Types

ARTICLE 3- (1) BEZMIALEM Scholarship for the undergraduate programs of VAKIF University can be realized in three ways:

- a) Success scholarship
- b) Full education scholarship
- c) Semi-educational scholarship

Success Scholarship

ARTICLE 4- (1) BEZMIALEM refers to the financial scholarship granted in addition to the tuition fee for the student who is studying at the VAKIF University.

(2) Among the students who apply for the graduate education, the number of the graduate students determined by the Rectorate and the Board of Trustees is supported by the success scholarship.

(3) Students working in any job, as well as foreign students and students in the Scientific Preparatory Program can not benefit from the Success Scholarship.

(4) Upon awarding the Success Scholarship, the following regulations and criteria shall apply:

a) Those who are graduate students and who are in the grade level are awarded a scholarship of success rate of 50% of the full-time research assistant who works in the program they are in.

b) Those who are graduate students and who are in the thesis phase,

60% of full-time research assistant salary

It is given.

c) Ph.D. students are awarded scholarship to 70% of the full-time research assistant who is in the program.

d) Successful scholarship students are awarded 80% of the full-time research assistant scholarship for the program they are successful in.

e) TUBITAK, TUBA and so on. scholarships from institutions can not benefit from the scholarship of success.

f) Undergraduate students who receive scholarships for success are assigned as assistant staff in all kinds of education, training and research activities of the related institute and department. Those who are in the course and thesis phase have to participate in the education and training activities (lectures, seminars, laboratory, supervision etc.) for at least three days a week, assist the researchers in research activities and take part in scientific activities.

g) BEZMIALEM while receiving scholarship for success.

graduate students and TÜBİTAK. scholarship

students' success scholarships are converted into full scholarship.

h) More scholarships than success scholarships determined by the Rectorate and the Board of Trustees

If the student is entitled to receive, the students who are not in the quota

the scholarship is converted into a full scholarship.

Success Scholarship Student Admission Requirements

ARTICLE 5- (1) Graduate degree average for graduate education is at least 2.75 / 4.00;

graduate GPA average of at least 3.00 / 4.00 for doctoral education and at least 3.25 / 4.00 of undergraduate GPA for those who begin direct doctorate education in lisanstan.

(2) Applicants are required to take at least 65 points for graduate education and at least 70 points for doctoral education in the relevant field of Academic Personnel and Postgraduate Education Entrance Examination (ALES).

(3) Candidates applying for a master's degree and doctoral degree must have got a score equivalent to at least 65 points from the international foreign language exams accepted as

equivalent to the central foreign language exams accepted by the Higher Education Council or international foreign language exams which are equivalent by ÖSYM .

(4) These averages can be kept as low as 15% for a single criterion by the reasoned recommendation of the president of the department and the approval of the Graduate School Board.

#### Full Education Scholarship

ARTICLE 6- (1) BEZMIALEM means that the student who is studying at the graduate school in Vakif University is exempted from tuition fees.

(2) Students who receive full education scholarships are assigned as assistant staff in all kinds of education, teaching and research activities of related institute and department. Those who are in the course and thesis phase have to participate in the education and training activities (lectures, seminars, laboratory, supervision etc.) for at least three days a week, assist the researchers in research activities and take part in scientific activities.

(3) BEZMIALEM Students working in any job other than the VAKIF University and foreign students and students in the Scientific Preparatory Program are eligible for the Full Study Scholarship

benefit.

#### Full Education Scholarship Student Admission Requirements

ARTICLE 7- (1) Graduate degree average for graduate education is at least 2.50 / 4.00;

graduate GPA average of at least 2.75 / 4.00 for doctoral education and at least 3.00 / 4.00 of undergraduate GPA for those who begin direct doctorate education in higher education.

(2) Candidates are required to take at least 60 credits for graduate education and at least 65 for doctoral education in the relevant field of Academic Personnel and Postgraduate Education Entrance Examination (ALES).

(3) Candidates applying for master's degree and doctoral degree are accepted as equivalent to central foreign language exams accepted by the Higher Education Council and international foreign language

at least 60 points from the examinations or international foreign language exams which are accepted as equivalent by ÖSYM.

(4) These averages can be kept as low as 15% for a single criterion by the reasoned recommendation of the program manager and the approval of the Graduate School Board.

#### Semi-Educational Scholarship

ARTICLE 8- (1) BEZMIALEM means that the student who is studying at the graduate school in VAKIF University is exempted from the tuition fee.

(2) Students who receive half-education scholarship, all kinds of education and training of related institute and department,

teaching and research activities. Those who are in the course and thesis phase have to participate in the education and training activities (lectures, seminars, laboratory, supervision etc.) for at least three days a week, assist the researchers in research activities and take part in scientific activities.

(3) BEZMIALEM Students who work in any job other than VAKIF University and foreign students and students in the Scientific Preparatory Program can not benefit from the Semi-Educational Scholarship.

#### Semi-Educational Scholarship Student Admission Requirements

ARTICLE 9- (1) Graduate degree average for graduate education is at least 2.25 / 4.00;

graduate GPA average of at least 2.75 / 4.00 for doctoral education and at least 2.75 / 4.00 of undergraduate graduation average for those who begin direct doctorate education in lisanstan.

(2) Candidates are required to take at least 60 credits for graduate education and at least 65 for doctoral education in the relevant field of Academic Personnel and Postgraduate Education Entrance Examination (ALES).

(3) Candidates applying for master's degree and doctoral degree are accepted as equivalent to central foreign language exams accepted by the Higher Education Council and international foreign language

at least 60 points from the examinations or international foreign language exams which are accepted as equivalent by ÖSYM.

(4) These averages can be kept as low as 15% for a single criterion by the reasoned recommendation of the program manager and the approval of the Graduate School Board.

#### Evaluation of Scholarship Applications

ARTICLE 10- (1) The applicants must submit the documents required in the application announcement together with the relevant Institute

It's done to your manager. Applicants are assessed by the Institute's Board of Directors within the framework of the quotas determined for each academic year and a ranking is made between them.

#### Scholarship and Scholarship Cutting

ARTICLE 11- (1) Every student who has been granted scholarship shall be appointed with the decision of the department

the counseling lecturer evaluates the scholarship status by monitoring the achievement status of the students and fulfilling their duties according to the above mentioned job descriptions.

The counseling faculty member has prepared periodic reports to the Institute regarding the presidency of the department.

(2) As a result of the evaluation of the reports by the Institute Administrative Board,

it is decided whether or not it should be done or not and the situation is reported to the Rector.

(3) Students who are eligible for scholarship and reduction are obliged to continue their programs.

(4) Scholarship is canceled for a student who has been granted a scholarship or a discount in the event of one of the following situations. The student who has canceled the scholarship pays the tuition fee for the remaining tuition fees at the applicable fees.

a) Absence of one semester without valid excuse,

b) Failure to complete graduate education within four semesters,

c) At the end of the two semesters in the master's program, the average grade point average Below 2.50,

d) Failure to complete the courses in doctoral program in 4 semesters,

e) Failure to complete doctoral program within 4 years,

f) In the PhD program, the overall achievement score is below 3.00 at the end of four semesters,

g) Not to take doctoral qualification examination until the end of the fifth semester

h) Failure from doctoral qualification examination,

i) The failure of the defense of the dissertation of the doctorate,

j) The rejection of the doctoral dissertation twice,

k) Failing twice or intermittently three times in the thesis monitoring committee or not participating in the thesis monitoring committee meeting,

l) Not to make defense of master / doctoral dissertation in the course of time,

m) Not to deliver documents required for graduation within the time limit,

n) Failure with F1 note,

o) Any disciplinary action taken,

p) Those who are assigned as assistant personnel in education, training and research activities should be absent for 5 days in a month without the valid excuse on the days determined by the relevant department,

q) For the reasons such as record clearing, graduation,

r) Deletion of the program record by the Institute for any other reason.

(5) The right to scholarship is granted only once at the beginning of graduate education. A student whose scholarship has been canceled or interrupted can not receive a scholarship again.

ARTICLE 12- The office of the Rectorate and the Board of Trustees shall decide upon the quota of the students who will receive success scholarship every term with the proposal of the Institute Directorate.

Removed Directive

ARTICLE 13 - The Directive dated 14.08.2015, published on the web page of Bezmiâlem Vakıf University, has been abolished from the enforcement.

Transitional Provisions

PROVISIONAL ARTICLE 1- (1) This Directive replaces the Directive dated 14.08.2015.

The students enrolled before the enforcement of this directive are also subject to the provisions of the İbu Yönergen.
